## Sadie Wins Westminster!!



Ch Roundtown Mercedes of Maryscot, aka Sadie, took best in show at Westminster as CTC members cheered in front of the 9 foot screen at Buffalo Beach. This is Sadie's 112 best in shown and one look at the photo above pretty much tells you why.

Terriers win Westminster more often than any other group by far (about 43% of the time) and Sadie is the 9th Scotty to win.

Sadie was born on April 2, 2005. Dad is Ch Anstamn Like A Rock and mom is Ch Maryscot Painted Black. The Owner is Amelia Musser.

Sadie is a triple Crown winner. She won the National Dog Show in November and the AKC/Eukanuba National Championship in December and winning Westminster makes her America's Top Dog.

The Wire Fox Terrier is by far the most frequent winner of Westminster (13) followed by the Scotty and then by the English Springer Spaniel (6). After that the Airdale Terrier, Smooth Fox Terrier, Sealyham Terrier, Boxer, Poodle (Standard) and Doberman Pinscher tie at 4 wins.

Looking at the oldest dogs to win Best in Show at Westminster, 5 of 11 are terriers. Looking at the youngest to win 5 of 10 are terriers. The first 4 Westminsters were won by a Smooth Fox Terrier and 8 of the first 10 shows were won by terriers. The first Scotty won (Ch Tickle Em Jock) won in 1911.

When it comes to winning Westminster the sporting group is second to the terriers but it isn't even close. They would have to win every year for the next 27 years just to tie the terriers. A highly unlikely event!

# Corrections to Treasurer's Reports of Nov and Dec 2009

During the February meeting Julie mentioned that the Treasurers report as published in last month's Lamppost contained an error. The error was the result of an omission of a \$870 deposit made on November 25, 2009 for Christmas pictures. Everything else including the ending balance was reported correctly.

In reviewing the December 2009 Treasurer's Report with Lynne Ward we noticed additional errors. The December report contained a addition error resulting

in an understatement of the ending balance by \$0.42. A payment to Rick Robillard for Lamppost Printing and Web Domain fees was reported as \$174.99 and should have been reported as \$174.49. A \$200 deposit paid to Rita Phoenix on September 9, 2009 for the fun day did not clear the CTC checking account until December 30, 2009. The payment is being added to the December Treasurer's report.

After adjusting for these 3 errors the ending balance for De-

cember 2009 originally reported as \$2018.00 is actually \$1818.92. This amount (the correct amount) was reported as the starting balance for January by Lynne during the February meeting. In other words, the errors had been corrected on the CTC books but not reported in the newsletter.

Since this can be a little hard to follow I decided to republish the November and December Treasurer's Reports and highlight the changes in red.

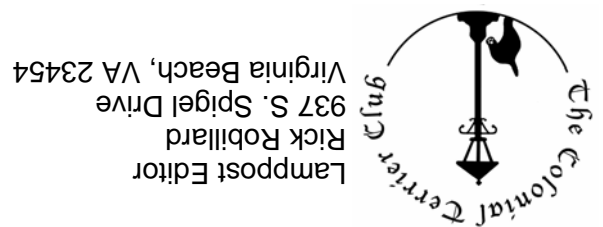
